

# Limited Warranty

## U-PVC cladding sheet range

**Between:** Arctic PVC, with its head office located at:  
Unit 12C, Goldthorpe Ind. Est. Rotherham, S63 9BL

**And:** ..... (Purchaser)

This product has been manufactured and tested to the highest quality standards by Arctic PVC. The limited warranty offered by Arctic PVC covers defects in material for U-PVC cladding sheet. This warranty extends to the original purchaser only and is non-transferable. Only consumers purchasing Arctic PVC products may obtain coverage under our limited warranties.

### What is covered

**Arctic PVC warrants this product against defects in material as follows:**

Arctic PVC will replace at no charge for replacement products that proves defective material, under normal installation, use, service and maintenance. If Arctic PVC is unable to provide replacement or cannot be made in a timely fashion, Arctic PVC may elect to refund the purchase price in exchange for the return of the product.

### How long does the coverage last

The warranty Arctic PVC offer periods are twenty (20) years from the documented date of purchase.

### What our warranty does not cover

**The warranty Arctic PVC offer does not cover any problem that is caused by:**

- A. Conditions, malfunctions or damage not resulting from defects in material.
- B. Conditions, malfunctions or damage resulting from (1) normal wear and tear, improper installation, improper maintenance, misuse, abuse, negligence, accident or alteration.
- C. Accessories or related products supplied by Arctic PVC. Our limited warranties are void if a product is installed using improper installation guidelines.

### How to file a claim

Arctic PVC will not provide any warranty coverage unless claims are made in compliance with all terms of the controlling warranty statement included with your product and you follow proper return procedure. To request warranty service, you will need to provide:

- 1. The sales receipt or other evidence of the date of purchase.
- 2. A detailed description of the problem.
- 3. Obtain a Return Merchandise Authorization (RMA) Number to use when returning the product. This number must be clearly marked on the exterior shipping packaging of the product. Products returned without an RMA number will be rejected, returned, or discarded.
- 4. Ensure package is carefully packed with a label addressed:

When warranty service is completed, any replacement product will be returned to you postage prepaid.

Replacement (or, in limited circumstances, refund of the purchase price) as provided under this warranty is the exclusive remedy of the purchaser.

Cladright™ shall not be liable to the purchaser or any other person for any incidental, special or consequential damages, arising out of breach of this warranty or any implied warranty (including but not limited to any implied warranty of merchantability).

### Liability for damages

To the maximum extent permitted by applicable law, in no event shall Cladright™ or its suppliers be liable for any damages whatsoever (including without limitation, installation costs, special, incidental consequential, or indirect damages for personal injury, loss of business profits, business interruption or any other pecuniary loss) arising out of the use of or inability to use this product.
